

PRIVACY POLICY

1. Overview

This Privacy Policy explains how **Bucks** (“Bucks,” “we,” “us,” or “our”) collects, uses, stores, protects, and discloses personal information, including non-public personal information (“NPI”), obtained from users through our website <https://www.usebucks.co> (the “Site”), as well as through other channels such as email, phone, and offline communications.

The Site is operated by Bucks to provide information about and access to our financial products and services (collectively, the “Services”).

We take your privacy and the security of your information seriously. This Policy explains:

- What information we collect and how we use it
- Choices available to you regarding the collection and use of your information
- How we protect personal information

This Privacy Policy forms part of the terms governing your use of the Site and Services. By accessing or using the Site or Services, you consent to the practices described in this Policy.

2. Information We Collect

Information You Provide to Us

We collect personal information you voluntarily provide when you:

- Create an account
- Apply for or use our Services
- Request information or customer support
- Subscribe to newsletters or communications
- Contact us via email, phone, or other channels

This information may include:

- Full name
- Residential or business address
- Email address
- Phone number
- Employment or professional information
- Financial or account-related information required to deliver our Services

Certain information may be required to comply with legal, regulatory, or identity verification obligations.

Information We Automatically Collect

When you visit or interact with the Site or our communications, we may automatically collect certain information using cookies or similar technologies, including:

- IP address
- Browser type and operating system
- Device information
- Date and time of access
- Pages visited and duration of visits
- Email interaction data (e.g., open and click-through rates)

You may adjust your browser or device settings to manage cookie preferences; however, disabling cookies may limit access to some features of the Site. Please note that our systems may not respond to “Do Not Track” signals.

3. How We Use Your Information

We use personal information in a manner consistent with this Policy and applicable laws, including to:

- Provide and operate our Services
- Verify identity and comply with regulatory obligations
- Respond to inquiries and customer support requests
- Process transactions and manage accounts
- Improve our products, services, and platform functionality
- Monitor and prevent fraud, unauthorized activity, and security risks
- Communicate updates, service notices, or marketing information (where permitted)

You may opt out of marketing communications at any time by following unsubscribe instructions or contacting us directly.

4. Sharing of Information

Bucks does **not** sell personal information. We may share information only in the following circumstances:

Service Providers and Partners

We may share information with trusted third-party service providers who perform services on our behalf (e.g., payment processing, data hosting, customer support). These parties receive only the information necessary to perform their functions and are required to protect it.

Corporate Transactions

In the event of a merger, acquisition, restructuring, or asset sale, personal information may be transferred as part of the transaction, subject to applicable privacy protections.

Affiliates

We may share information with our affiliates or subsidiaries, where applicable, for purposes consistent with this Policy.

Legal and Regulatory Obligations

We may disclose information if required by law or in good faith to:

- Comply with legal or regulatory obligations
- Protect the rights, property, or safety of Bucks, users, or others
- Prevent fraud or enforce agreements

5. Third-Party Links

6. Children and Minors
